A reversal signal?

VN30 performance

After two sessions of gains, the VN30Index underwent a slight correction, down 0.54% to close at 1,916 points. Selling pressure persisted in TCB (-2.58%), MSN (-1.75%), FPT (-1.68%), SAB (-1.55%), VNM (-1.51%), LPB (-1.49%), GVR (-1.23%), STB (-1.21%), and VCB (-1.17%). On the other side, buying demand held up in VIC (+0.92%), GAS (+0.86%), and BSR (+0.60%).

VN30 Future chart: A reversal signal?

Selling pressure emerged at the higher price zone, which produced a long-bodied red candlestick and formed a Bearish Engulfing reversal pattern. This points to the possibility of a reversal in the short term.

In addition, the contract still closed below both the 50-period and 100-period moving averages, while liquidity has declined steadily over the past two weeks since the bottom was formed.

That said, further confirmation signals remain necessary to determine the next trend, as the contract continued to close above the 20-period moving average - the third consecutive session above this line. This suggests an upward trend in the short term.

In the next session, the 1,800-point level should serve as strong short-term support, while the 1,950-point area should act as strong resistance, a zone that coincides with the 50-period and 100-period moving averages.

Technical strategy

The signals remain inconsistent, and liquidity stays at a low level. Investors should therefore wait for confirmation signals before they reopen new positions.

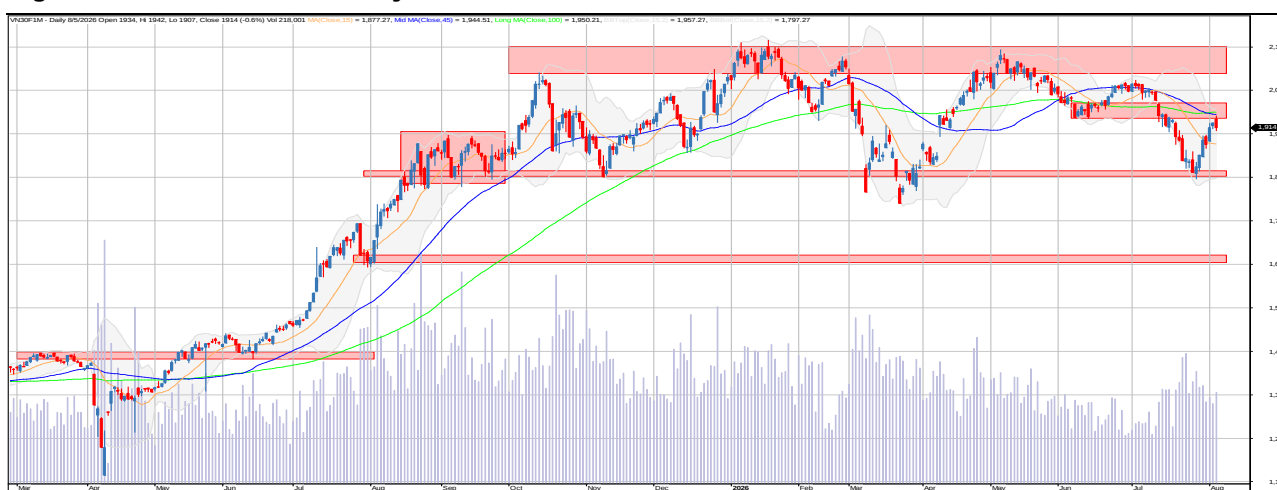

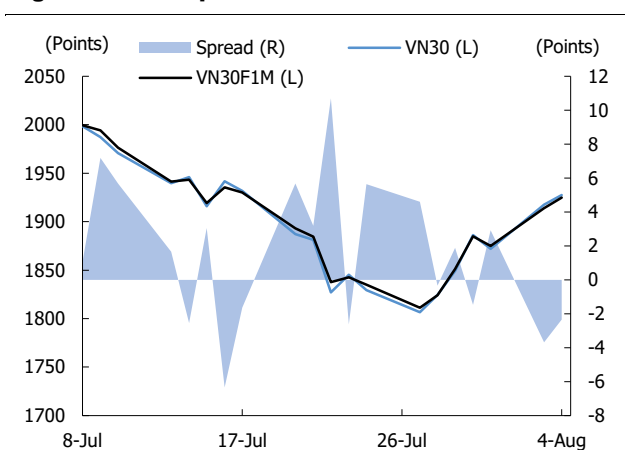

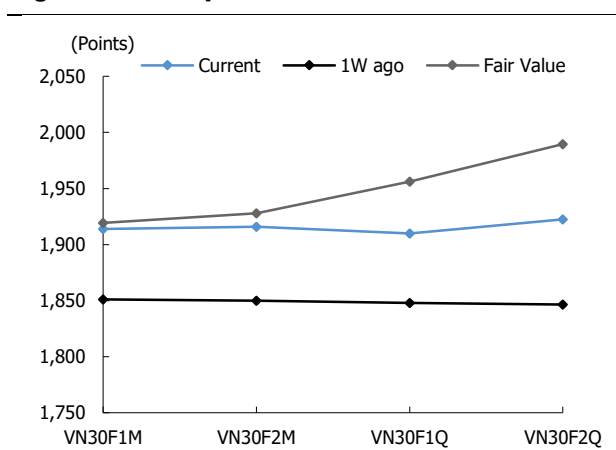

Figure 1. VN30F1M Generics daily chart

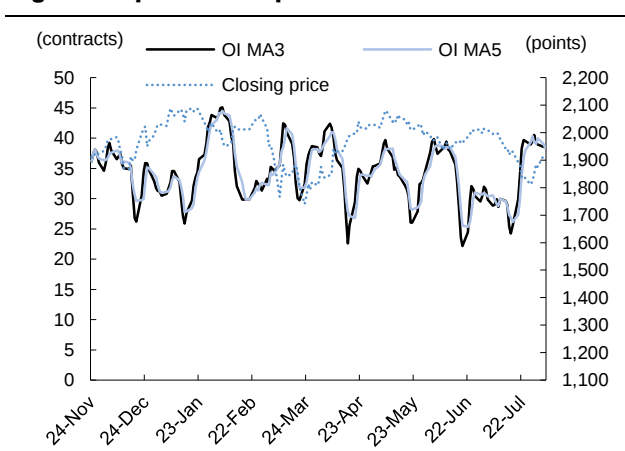

Figure 2. Basis spread

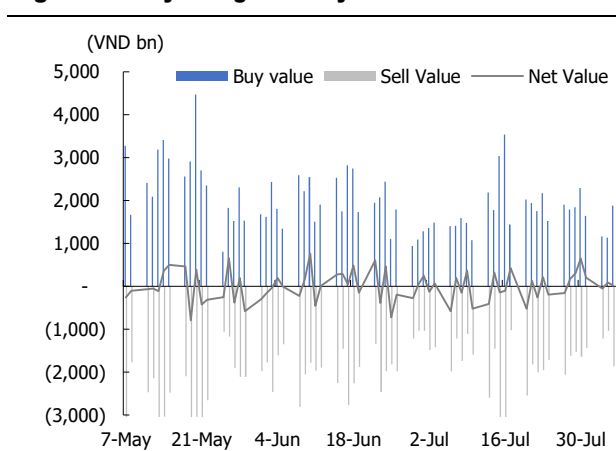
