Awaiting further signals

VN30 performance

The VN30Index recorded its second consecutive gaining session, rising 0.74% to 1,942 points. Accordingly, 16 constituent stocks advanced, led by VIC (+4.63%), HPG (+2.53%), VPB (+2.53%), SSI (+2.41%), VHM (+2.37%), and BSR (+2.05%). Conversely, selling pressure persisted on LPB (-1.80%), SAB (-1.50%), ACB (-1.10%), and CTG (-1.09%).

The market maintained positive signals as it advanced. The contract also closed above its 10-, 20-, and 50-period moving averages for the second consecutive session, which implies confirmation of the short-term uptrend.

However, investors should monitor additional signals in today's session, as liquidity declined yesterday and two of the three candles in an Evening Star pattern have already formed. Should the third candle appear, risk may increase. Therefore, further confirmation signals for the upcoming trend remain necessary.

In the next session, the 1,800-1,820 point range will serve as strong short-term support (this corresponds to the bottom formed in late Jul 2026). Meanwhile, the 1,960 point area will act as strong resistance, coinciding with the 100-period moving average.

Technical strategy

The uptrend has been confirmed, but further signals warrant observation given the decline in liquidity. Therefore, traders may reopen Long positions once confirmation signals emerge.

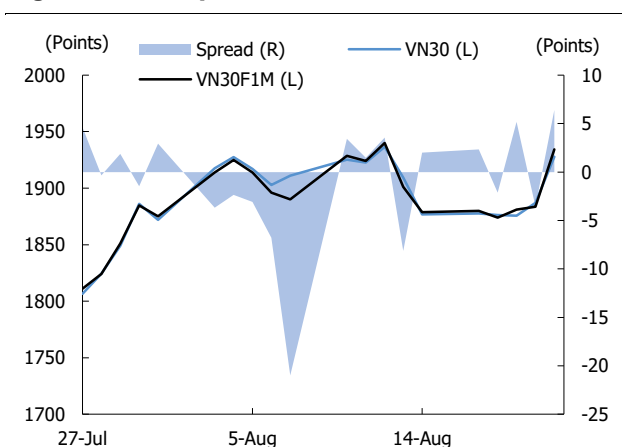

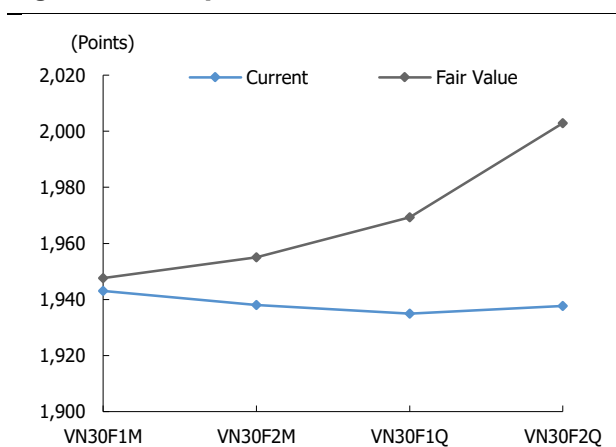

Figure 1. VN30F1M Generics daily chart

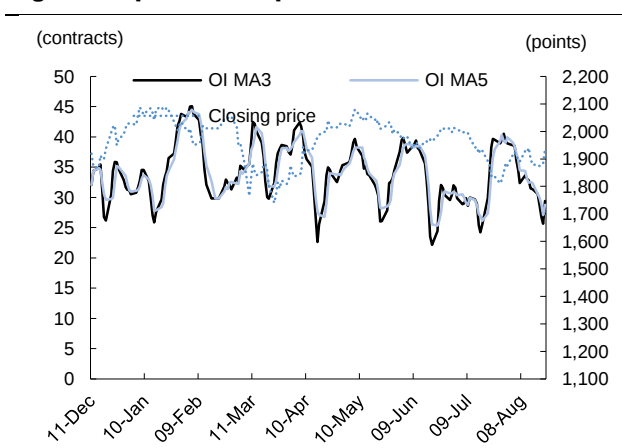

Figure 2. Basis spread

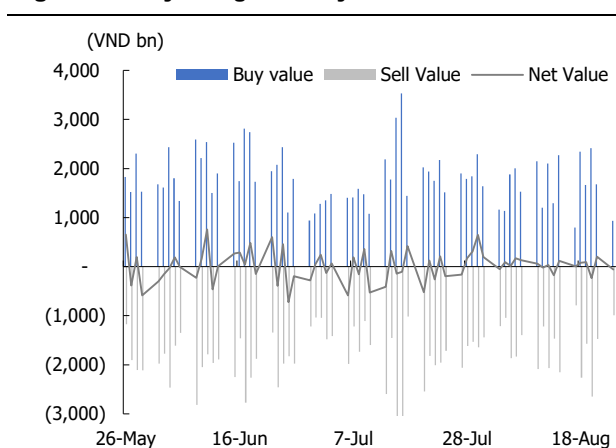
