Selling pressure has emerged

VN30 performance

After two consecutive gaining sessions, the VN30Index underwent a correction, falling 0.30% to 1,936 points. Accordingly, 19 constituent stocks declined, led by BSR (-2.55%), HPG (-2.02%), GAS (-1.76%), MWG (-1.60%), HDB (-1.46%), ACB (-1.33%) and TCX (-1.23%). On the other side, buying demand emerged in VIC (+2.80%), SSB (+2.26%), MCH (+1.50%) and LPB (+1.43%).

VN30 Future chart: Selling pressure has emerged

The market invalidated the Evening Star pattern, yet formed a candlestick with a small body and a long upper shadow. This implies that selling pressure has emerged, particularly as liquidity remained at a high level during the session.

The signals lack consistency, given that the contract still closed above the 10-, 20- and 50-period moving averages. This confirms the short-term uptrend. Therefore, further confirmation signals for the upcoming trend remain necessary.

In the next session, the 1,800-1,820-point range will serve as strong short-term support, as this zone marks the bottom formed in late Jul 2026. Meanwhile, the 1,960-point area will act as strong resistance, coinciding with the 100-period moving average.

Technical strategy

Since the signals lack consistency, additional signals are needed to confirm the trend. Traders should therefore stay on the sidelines and reopen long positions only once such a signal appears.

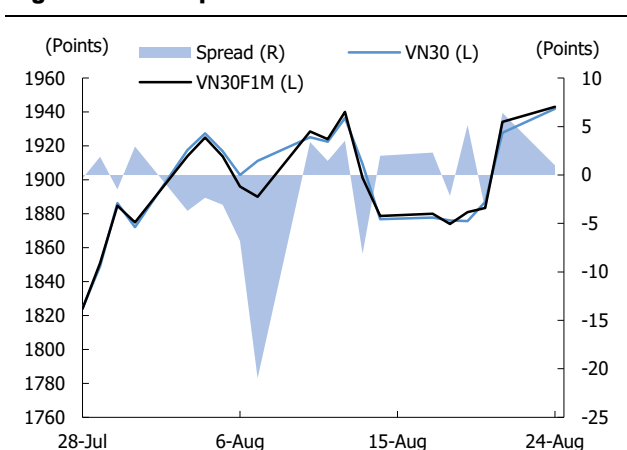

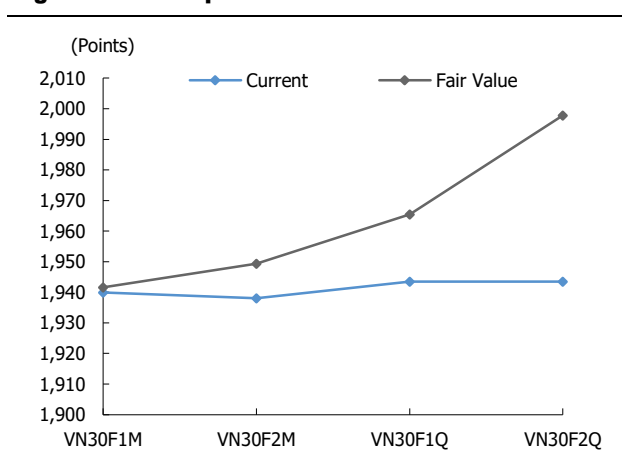

Figure 1. VN30F1M Generics daily chart

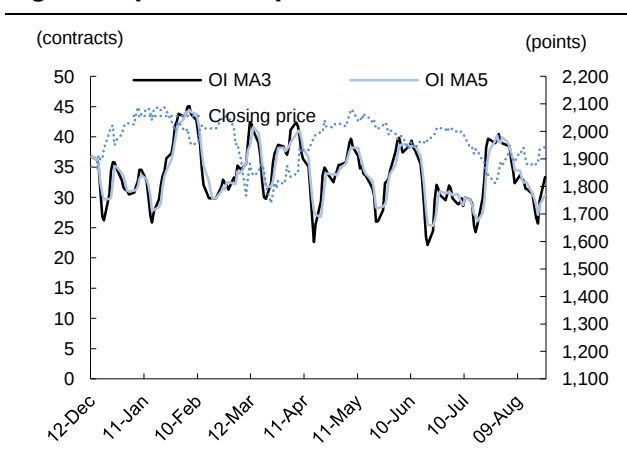

Figure 2. Basis spread

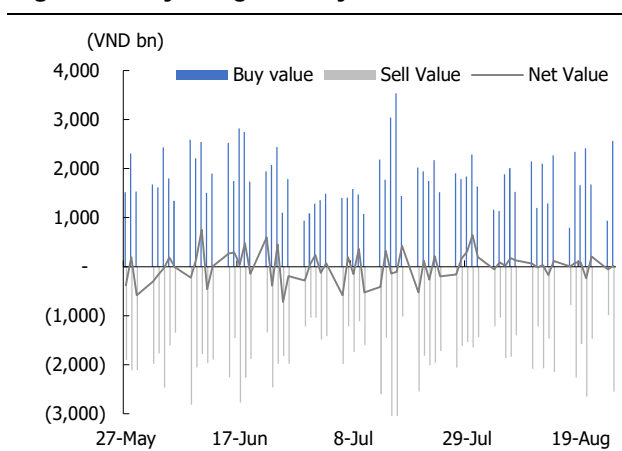
